InteliGro (Pty) Ltd (Wellington) NEMA Section 24G Application

NOTICE OF A RECTIFICATION APPLICATION IN ACCORDANCE WITH THE ACTIVITIES IDENTIFIED IN TERMS OF THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS, READ WITH SECTION 24(G) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT NO. 107 OF 1998) (NEMA) (AS AMENDED) FOR INTELIGRO (PTY) LTD (WC DEA&DP REF: 14/2/4/1/B3/38/0012/22)

Notice is, hereby, given in terms of Section 24(G), read together with Section 24(F) of the National Environmental Management Amendment Act, 2004 (Act No. 8 of 2004) (NEMA) (as amended). The Western Cape Department of Environmental Affairs and Development Planning (DEA&DP) is considering an Application for *ex post facto* approval by InteliGro (Pty) Ltd, in terms of Sections 24(G) and 24(F) of the National Environmental Management Amendment Act, 2004 (Act No. 8 of 2004) (as amended), as well as in terms of the Environmental Impact Assessment (EIA) Regulations, under the sub-regulations of Government Notice Regulation (GN) R.387 (dated 21 April 2006) and (GN) R.984 (dated 04 December 2014), as amended on 07 April 2017 by (GN) R.325, published in terms of the NEMA.

NATURE OF APPLICATION:

InteliGro (Pty) Ltd is an existing depot/dangerous goods storage facility, located at 3 Marchand Street, Wellington, Western Cape. InteliGro commenced operations on Portion 0 of Erf 1569 in May 2008. The existing warehouse building (with receiving area) occupies a total footprint of \sim 4 000 m2. However, InteliGro only occupies a portion of the warehouse building for the storage of the dangerous goods. The InteliGro depot, thus, occupies a footprint of only 2 000 m2. The Application for Rectification is being made in terms of the:

NEMA: Activity Number 4 of (GN) R.984 (2014 NEMA EIA Regulations, as amended on 07 April 2017) (Listing Notice 2).
